## STATE MENUDO COOK-OFF RULES

1. Gates will open at 5:00 a.m.
2. All cook-off applications must be signed and the appropriate entry fee paid by no later than **Saturday, May 3, 2008 at 12:00 p.m.**
3. **Contestants must fully prepare their Menudo entry on site at their assigned cook-off areas.**
4. Contestants will be issued an official "menudo bowl", which must be used for presenting your menudo entry for judging. All bowls are identical and must not be lost or altered in any way; to do so will warrant disqualification.
5. All official "menudo bowls" must be ready to be delivered by **3:00 p.m.** on the day of the cook-off.
6. There will be 13 judges chosen from among the cook-off contestants, names to be submitted on the applications. Selection of the judges will be public and will be held at **4:00 p.m.** at the cook-off stage. Judging will begin thereafter.
7. Contestants may **NOT** sell any food or drink items, but may give free samples of their menudo.
8. Contestants by signing this application agree to abide by all rules, safety regulations, and agree to accept final decisions made by judges.
9. All menudo entries become property of the 2008 VIVA! Cinco de Mayo & State Menudo Cook-Off.
10. Contestants will enter through the back eastside gate; **NO VEHICLES** will be allowed inside the fenced area. Any vehicle found in the fenced in area will be towed at the **owner's** expense. **Only Contestants displaying a state-issued disabled person license plate or hanging tag will be allowed to bring there vehicle inside the fenced area.** The vehicle **MUST** remain within the confines of the assigned space. For safety reasons, vehicles **CANNOT** be brought inside the fenced area to remove menudo booths until after **10:00 p.m. on Saturday, May 3, 2008.**
11. There will be a **mandatory** meeting for all Cook-Off Teams on **Saturday, March 29, 2008 from 4:00 p.m.-7:00 p.m.** at the **Tire Factory Outlet**. For those teams unable to attend this meeting there will be a **follow-up** meeting on **Saturday, May 3, 2008 at 11:00 a.m.**
12. **There is a total limit of two (2) cases of beer per each five-member team allowed. Any beer in excess of the amount allowed will be confiscated and become the property of VIVA! Cinco de Mayo Inc. No beer may be brought in after 10:00 a.m. Failure to comply will warrant disqualification. Head Cook can purchase up to three (3) cases at a \$1.00 a beer. We appreciate your cooperation and participation and ask that you support our concessions and help us in providing our future leaders with a quality education.**
13. All menudo booths must be removed by **12:00 p.m., Sunday, May 4, 2008.** Any booths left remaining will be thrown away. (no exceptions)

## BBQ COOK-OFF RULES

1. Gates will open at 5:00 a.m.
2. **Check In Times** on Saturday, May 3, 2008;
  - 8:00 a.m.-for unregistered teams
  - 9:00 a.m.-for registered teams (paid in full)
3. **Meat Inspection:** At check in time. All meat **MUST** be inspected before entering the cook-off. Pre-cook-off marinating or seasoning must be done at the cook-site for brisket entries. **\*\*\*ONLY FAJITAS MAY BE PRE-MARINATED\*\*\***  
All raw meats must be checked in before being placed on the pits. Once, meat has been checked in, **IT MUST NOT LEAVE THE CAMPSITE.**
4. The Head Cook will be given a container for each entrée that he/she will enter. Please make note, the containers given to you will be the only ones accepted for Judging. **NO ENTRY DECORATIONS (Garnishes, etc.) ARE PERMISSIBLE.**
5. Each category will be judged on the following: **Appearance, Aroma, Taste, Tenderness and Cut. Each entry must have 30 bite size pieces and one piece for presentation.** All boxes are identical and must not be lost or altered in any way; to do so will warrant disqualification.
6. Check-In Times for Judging of Entries:

Please allow yourself five minutes Before check-in to insure timely arrivals.	
Fajitas—12:30 p.m.	Brisket—4:00 p.m.
7. Judges will be selected by Viva! Cinco de Mayo.
8. Contestants may **NOT** sell any food or drink items, but may give free samples of their entries.
9. All BBQ cook-off entries become property of the 2008 VIVA! Cinco de Mayo & State Menudo Cook-Off.
10. Contestants will enter through the back eastside gate; **NO VEHICLES** will be allowed inside the fenced area. Any vehicle found in the fenced in area will be towed at the **owner's** expense. **Only Contestants displaying a state-issued disabled person license plate or hanging tag will be allowed to bring there vehicle inside the fenced area.** The vehicle **MUST** remain within the confines of the assigned space. We appreciate your cooperation and participation and ask that you support our concessions and help us in providing our future leaders with a quality education.**
13. All booths must be removed by **12:00 p.m., Sunday, May 4, 2008.** Any booths left remaining will be thrown away. (No exceptions).
